### EQUIPPING HISPANIC PASTORS FOR PASTORS FOR EFFECTIVE MINISTRY AND ADVOCACY

PJ's Equipping Ministries Fellowship (EMF) supports pastors of Hispanic-led congregations with valuable resources on topics such as institutional religious freedom and the opportunities and challenges of partnering with government.

This year, 26 ministries completed the EMF cohort in Dallas, with several receiving mini-grants from CPJ to implement a project to put the lessons learned into practice.



"EMF showed us the value of collaborating with community partners. With CPJ's mini-grant project, our church connected with local institutions like an immigration center, a Medicare agency, and a cancer care center. Together, we'll host six monthly breakfasts where these organizations will share information about their services. These sessions will help our community access resources, assist others in need, and strengthen ties between our church, local institutions, and the neighborhood."

### NAVIGATING CHALLENGES FOR FAITH-BASED ORGANIZATIONS

In October 2024, CPJ's Stanley Carlson-Thies collaborated with CPJ Fellow Chelsea Langston Bombino and CPJ intern alumnus Caleb Acker to offer the workshop "How to Help Ministries Keep or Recover Their Faith" at the Christian Legal Society National Conference. This session equipped lawyers with the tools and insights needed to guide ministries facing legal challenges, helping them protect their faith-based missions.

### TRAINING AND EMPOWERING ADVOCATES FOR PAID FAMILY LEAVE

CPJ's Families Valued team convened advocates for paid family leave in Texas to meet with their representative's office. These meetings fostered connections among faith leaders, grassroots maternal health organizations, and policymakers, paving the way for legislative change.

CPJ provided training to advocates, equipping them to share personal experiences with paid family leave, how access (or the lack thereof) has shaped their lives, their parenting journeys, and how their faith strengthens their commitment to this cause.

## STRENGTHENING FAITH-DRIVEN LEADERSHIP ON CAPITOL HILL

n the past year, 39 Capitol Hill staffers completed CPJ's Civitas Fellowship for Congressional Staff, a bipartisan, four-month Christian leadership development program that equips participants with a Neo-Kuyperian approach to public service. The program helps staffers integrate faith with how they think about their work on Capitol Hill and pursue their vocations with purpose and a commitment to public justice.



"Oftentimes, I'm in policy circles where I may agree with others on the end policy goal, but we may not share the more foundational reasons as to why we have that goal. And the why really does matter. It was helpful to understand and discuss both the ends and the means of our policy work, and to learn how to step back and think about where I may agree with people I normally disagree with at work."

### ASSESSING AND RENEWING THE FAITH-BASED INITIATIVE

Insights from Stanley Carlson-Thies

Stanley Carlson-Thies, Senior Director of CPJ's Institutional Religious Freedom Alliance, has played a key role in the development of the faith-based initiative, which seeks to foster effective collaborations between government and faith-based community organizations to address social challenges.

In his contribution to the "Spirited Debate" essay series by the University of Pennsylvania's Program for Research

on Religion and Urban Civil Society, Carlson-Thies offers a comprehensive assessment and actionable recommendations for rejuvenating the faith-based initiative.

### **NEW RESEARCH**

#### Faith in Child Care Settings

A 2020 survey by the Bipartisan Policy Center found that faith-based child care remains a popular choice for many families, but little research exists on the child care sector's faith-based component.

To address these knowledge gaps within child care settings, Rachel Hope Anderson, CPJ's senior consultant on this project, in partnership with Baylor University's Institute for Studies of Religion, initiated a survey of child care


providers in Georgia and Massachusetts. This second set of state-based research reveals the diverse ways in which faith is expressed within child care settings, providing valuable insights for policymakers seeking to include faith-based providers in the broader child care ecosystem.
